# Great New Expansion of the Gift of Life Program

After 10 years of being a critical blood supplier and receiving national acclaim for its efforts, the Gift of Life Special Committee, in consultation with the Texas Masonic Hospitals, has been updated and reorganized to better serve the hospitals, their patients and the Masons of Texas.

A fundamental part of the reorganization was to adopt the following mission statement to properly direct the program's future:

## G.O.L. Program Mission Statement

*"The Masons of Texas will work together through facilitating blood drives in their local communities and Blue Lodges to provide enough blood to support and supply the three Masonic Hospitals in Texas, as well as the other hospitals in the state."*

Another key to progressing forward was to acknowledge that future growth would be directly tied to the amount of involvement of non-Masons at the blood drives. This will

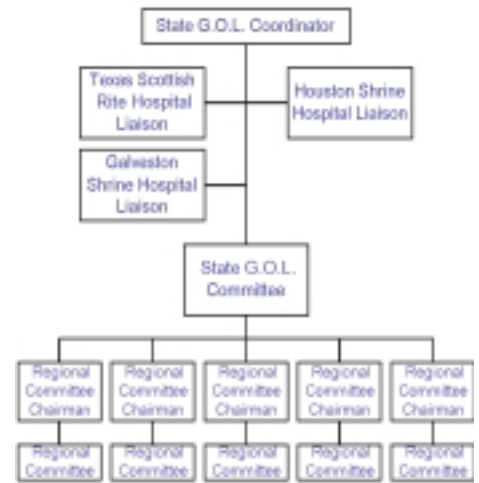
require more publicity about the program and it was decided that an awareness rally should be held with as much media coverage as possible.

# *Fiat Lux Conference*

*November 14 - 16, 2003*

**A 2003 SIGNATURE PROGRAM**

The **Fiat Lux Conference** will bring together Masons interested in learning the inside workings of Grand Lodge and in gaining the knowledge that will help them mold the future of Texas Freemasonry.

Each student will select 4 courses out of a total of 16 presented, all taught by expert Masons. The topics include:

Role of the Past Master - Study the Past Master's role in the local and Grand Lodge as he provides leadership to new Worshipful Masters and emphasizes the importance of the vote in the Grand Lodge legislative process.

DDGM's and the District Service Team - Examine the Service Team selection process. Discuss their training, how responsibilities are assigned, the ways Grand Masters have utilized members and how the Service Team concept may change.

Grand Lodge Legislative Process - Discuss the Constitution and Statutes, their differences and the process to create and amend Masonic laws. Discuss the Grand Master's authority to render Decisions and issue Proclamations and Edicts.

Masonic Home & School - Discuss the structure, funding, development staff, educational requirements, transfer student program and future plans and needs.

Grand Lodge Trustees - Examine Grand Lodge laws and civil statutes governing the Trustees. Discuss their powers both individually and as a body and compare their authorities with other Grand Lodges.

Recent and Current Changes in Grand Lodge Law - Review changes in Grand Lodge law, their effect on Lodges and Grand Lodge, and legislative trends. Examine the limits in the legislation progress in Masonry and discuss future legislative agendas.

Texas Masonic Endowment Programs - Discuss the endowment programs available to Texas Masons, their purposes and differences. Examine income sources, eligibility rules, and funds disbursement.

Masonic Philanthropies - Identify national charities supported or sponsored by Masons. Review services available, identify those eligible for assistance and learn what more can be done to assist the public.

The Grand Secretary's Office - Examine office operations, employees and their duties. The Grand Secretary will discuss services offered, merchandise and supplies sales, data maintenance, and services not the office's responsibility.

Grand Lodge Internet - Learn to use electronic resources available to Lodges. Get upcoming event information, locate Lodges, read Masonic history, learn to use e-mail for communications. Learn to create and maintain a Lodge web site.

Grand Lodge Financial Structure - Review Grand Lodge finances, asset distribution, total resources, investment policy, income sources, annual budget process. Distinguish between Grand Lodge funds and those held in trust for the Lodges.

Masonic Education from Potential Member to the PM - Review Masonic education available: Candidate Information System, ALL and LIFE Programs, Grand Master's Conferences, workshops, MWSA meetings and Masonic research bodies.

Future Goals and Objectives for Texas Masonry - Discuss key decision points at which we must respond to the challenge of an evolving Fraternity. How can we allow the Craft to grow and yet retain our adherence to the landmarks?

Public Relations: Marketing Masonry - Review Grand Lodge public relations programs, their costs and results, including discontinued programs and successful programs of other Grand Lodges. Discuss how Lodges can utilize Grand Lodge public relations programs.

Grand Lodge Committees - Review current committees, differences between Permanent, Temporary and Special Committees, duties assigned and how each functions. Examine committee creation and appointments, why they are necessary, and potential committee changes.

# Brother Merton Singer Chapel Builder

When Merton Singer entered the United States Military Academy at West Point in September 1934, attendance at religious services was compulsory. When asked, "What religious services do you want to attend – Catholic or Protestant?" Singer answered, "Sir, I am Jewish." After being given no other options, Singer replied, "Protestant," and, for four years, he attended Protestant religious services on Sundays.

With no opportunity for a Jew to worship at West Point during the High Holy Days, Singer enlisted the aid of a civilian Rabbi Bloom who agreed to conduct services for Jewish cadets on the holidays and every Saturday afternoon, which Singer attended with a handful of other Jewish cadets.

For more than 25 years, Singer dreamed of a Jewish chapel on the West Point campus and in 1960, circumstances allowed him to help found the West Point Jewish Cadet Chapel Committee. He successfully procured West Point and Department of the Army approval to build the chapel and after a site was selected, a successful fund drive was held and the chapel was completed in 1984. In 2003, a plaque was placed in the chapel honoring Merton Singer's role.

Singer retired from the Army as a Colonel in 1965, having served in various

commanding officer positions. As a junior officer in 1942, he invented a field method for distilling water and an automatic re-supply for petroleum products that reduced paper work by 98%. In 1948 he invented a "Geoguide," a device that helps locate oil deposits in the earth and is still in use today.

Singer received many awards - the Bronze Star, Legion of Merit, Royal Yugoslav Commemorative War Cross and the French Croix de Guerre with Palm. French President Charles De Gaulle presented him the Order of the Black Star, the highest medal given a non-Frenchman working with the French government.

Merton Singer was a First Lieutenant with the 2<sup>nd</sup> Infantry stationed at Ft. Sam Houston in San Antonio when he was raised to the sublime degree of Master Mason in Army Lodge No. 1105 on April 14, 1939.

After retiring from the Army, Brother Singer and his wife became residents of San Antonio and reared two sons and have two grandchildren.

Brother Merton Singer passed away on Monday, July 28, 2003.

## Q & A Texas Masonic History

**Did the Grand Lodge of Texas charter any Lodges in Greer County, Texas before it was declared part of the Oklahoma Territory?**

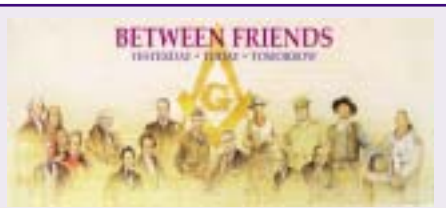
Greer County, Texas was opened for cattle grazers in 1860 and was homesteaded during the years 1885-1896. It was bound on the West by the 100th Meridian, on the North and East by the North Fork of the Red River, and on the South by the Prairie Dog Town Fork of the Red River.

The limits of that part of Texas had been established by the Louisiana Purchase in 1803 and The Boundary Treaty between the United States and Spain in 1821.

The Grand Lodge of Texas chartered two Lodges in Greer County. **Magnum #685**, held at Magnum, was chartered on Dec. 12, 1889, and **Altus #711**, held at Altus, was chartered on Dec. 11, 1891. But on March 16, 1896, the United States Supreme Court held that the county was part of Oklahoma and both Lodges were transferred to the Grand Lodge of Oklahoma in 1896.

**#8:** To create a written record of non-esoteric portions of the ritual.

## *Final Message from the Grand Secretary*

To the Secretaries:

We have all heard the statement, "You are someone's image of Freemasonry," which implies that our organization is judged by our thoughts, words and deeds.

I still vividly recall that as a young lad of only 10 years, our Sunday school teacher told us that each of us was admired and respected by others, and because of that, we influenced other's lives. I immediately dismissed that as textbook rhetoric, or standard teaching material because I was firmly convinced that I, as a 10-year-old boy, had absolutely no influence whatsoever on anyone else, and the lesson applied only to adults.

A scant two years later, a young neighbor boy proved my teacher correct. The lad played at our house, mostly with my younger brother, and I, being a big 12 years old, looked upon this lad of only 9, as a pest, and paid little attention to him. One day however, for some unknown reason, I decided to part my hair in the middle, believe it or not, as a 12 year old, I did have hair. Anyway, the very next day, this nine year old began parting his hair in the middle also. I was stunned, and the words of my Sunday school teacher reverberated throughout my entire mind. She was absolutely correct, and I was totally wrong.

Many years ago, a world-renown Hindu leader, was attributed as stating, that he would have become a Christian, except that he had seen too many Christians. Whether he actually said that or not, I do not know. But I do know, that we all influence other people, and that influence can be for better or worse.

Again, it is frightening to realize, that through our words and deeds, we have either attracted people to our Fraternity, or repelled them from us. And if we happen to attract them, what kind of a member will they become? Do you suppose they will be like us? I think you will agree, it is an awesome responsibility.

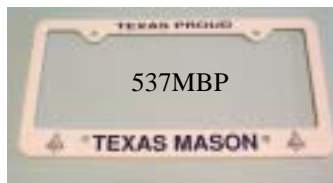
