# 2004 Brings A Three Tiered Approach To Personal and Masonic Growth

Since 1973, Texas Grand Masters have held Regional Conferences with presentations related to Masonic education and leadership, and an opportunity to visit with the Grand Master. In 2004, these elements will be delivered through three separate programs.

## Three Elements

Grand Master's Official Visits

Wardens' Retreat Program

Randall E. Briscoe  
Masonic Education  
Workshop Program

The opportunity to visit with the Grand Master will be accomplished through the revival of the **Grand Master's Official Visits** to Masonic Districts throughout the State. These Official Visits will allow the Grand Master to discuss the state of Texas Freemasonry and the business affairs of the Grand Lodge directly with the Brethren. For a list of Official Visits see the calendar on Page 10 or check the Grand Lodge website.

The leadership component will be provided through the **Wardens' Retreat Program**. This important program has been expanded to six weekend retreats in 2004. The Wardens' Retreat Program is developed for Senior and Junior Wardens, but is open to all interested Masons.

Finally, the Masonic education portion will be presented through the **Randall E. Briscoe Masonic Education Workshop Program**. This program, started in 1958 by then Grand Master Randall E. Briscoe, was discontinued in 1969. The program will be reinstated in 2004, and will be renamed in honor of Grand Master Briscoe.

The Workshop Program has three primary objectives:

(1) To provide a forum to discuss the allegories and symbolism of Freemasonry

(2) To stimulate the intellectual curiosity of the individual Freemason and encourage him to pursue a deeper understanding of the teachings of Freemasonry

(3) To assist Lodge officers develop an improved understanding of the Fraternity they serve as officers.

The State of Texas has been divided into 25 Areas, each incorporating several Masonic Districts, with multiple Workshops being held in each Area under the direction of an Area Workshop Chairman.

The workshop presentations will stimulate the individual to consider the moral and ethical teachings of the Fraternity and re-examine his relationship and obligation to God, his family, his community and his fellow Freemason. Each Mason must determine for himself the meaning and interpretation of the Fraternity's ritual, allegory and symbolism. That diversity of interpretation will be a strength of the Workshop program and everyone is encouraged to participate in the discussion.

Additionally, these Workshops will show Lodge officers how regular Masonic education programs can be a stimulating component of their Lodge meetings and provides the membership an opportunity to study Freemasonry. It also gets more than just the officers involved in a meeting, and keeps all brethren involved with their Lodge.

The Masonic Education and Service Committee, with the approval of the Grand Master, has developed the **Honor Roll** for Lodges that achieve outstanding Lodge Officer attendance at the Area Workshops. An appropriate Award will also be presented to the Lodge at an Area Workshop held in the next succeeding Workshop period.

The rules for qualifying for the Honor Roll and Awards are as follows:

(1) The regularly installed **Worshipful Master, Senior Warden, Junior Warden, and Secretary** of the Lodge must actually be present in person for the full presentation of the Masonic Education Workshop material and be correctly registered at a regularly scheduled Workshop held in the Workshop Area in which the Lodge is located; AND

(2) **IN ADDITION**, there must be present in person for the full presentation of the Workshop material and be correctly registered at a regularly scheduled Workshop held in the Workshop Area in which the Lodge is located **at least five of the of the following regularly installed Officers** of the Lodge: Treasurer, Chaplain, Senior Deacon, Junior Deacon, Senior Steward, Junior Steward, Marshal, Master of Ceremonies, Musician and Tiler.

(3) The Honor Roll Award will be based on the total number of officers attending during each Workshop period, subject to the requirements of 1 and 2 above.

Gold Award	11 or more officers
Silver Award	10 officers
Bronze Award	9 officers

Further information is available from your Area Workshop Chairman.

Also, all attendees will receive a Grand Master's coin at both the Spring and Fall Workshops.

He was instrumental in the planning and construction of a new Lodge building and served the Lodge as Worshipful Master in 1994-95. An Endowed member, he received the Golden Trowel Award in 1998. He is also a member of Henry Thomas No. 278 and Tranquility No. 2000, where he was the charter Tiler.

Brother Broughton has served the Grand Lodge and District 8 through his appointments as District Education Officer in 1996 and District Deputy Grand Master in 1997. He also served as Grand Tiler in 1998 and Grand Orator in 2003.

He served on the Grand Lodge Credentials No. 2 Committee in 1995 and the Committee on Masonic Education and Service from 1999-2003. He was a planning team member for PGM's Harry Cunningham, Michael Nanny and Boyd Patterson. This member of the Sam Houston Hall of Fame is currently the Grand Representative to Delaware.



Brother Broughton also works in the York Rite where he is a Past High Priest of Greenville Chapter No. 114 and was District Deputy Grand High Priest, 2001 – 2003. He is also a member of the Commandery, Knight Masons, York Rite College and the Allied Masonic Degrees.

A very active member of the Order of the Eastern Star, Brother Broughton is a Past Patron and the current Worthy Patron of

Caddo Mills Chapter No. 82. He was also the Grand Representative of Australia in Texas 2000-2002 and served on several Special Committees of Past Grand Matrons.

Brother Broughton is a member of the Dallas Valley of the Scottish Rite where he is the 16<sup>th</sup> Degree Master. He is also a member of Hella Shrine and Alla Grotto.

Originally from Louisiana, Brother Broughton graduated from Louisiana Tech University in 1974. He held many positions for L.L. Brewton Lumber Co., Inc. and is now the owner of Donald Broughton Enterprises Inc.

A devoted church member, he was a Sunday School teacher at the First Baptist Church of Winnfield, LA. After moving to Texas he was a Sunday School teacher, Elder and the Interim Choir Director at the Faith Bible Church of Caddo Mills. He currently attends the First Baptist Church of Rockwall.

# Grand Lodge Legislative Update

Following is a recap of the voting on the Resolutions proposed for consideration at the 2003 Grand Annual Communication.

Not considered: No. 2

Withdrawn: 12, 17, 18, 19, 20, 23, 24, 28, 29, 39

Tabled: 21, 22, 25, 37, 38

Failed: 5, 6, 7, 8, 9, 31, 32, 33

**Holdover Resolution No. 6, 2002:** Adds Art. 14e authorizing local Lodges to nominate Texas Masons to receive the Daniel Carter Beard Masonic Award for their service to the Boy Scouts of America.

**No. 1:** Amended Art. 338a by further defining authorized sources of Lodge information for historical and genealogical purposes.

**No. 3:** Changed the name of the Committee on Public Relations to the Committee on Communication.

**No. 4:** Directed the Take Time to Read Committee to make recommendations at the 2006 Grand Lodge session as to the feasibility of either adopting the TTTR Program as an official Grand Lodge Program or such other options at the discretion of the 2006 TTTR Committee.

**No. 10:** Revised the questions asked a Petitioner on Form No. 28, Investigation Report.

**No. 11:** Amended Art. 412 to eliminate duplication in Grand Lodge Law by removing information that is also contained on Form No 28.

**No. 13:** Amended Art. 335 to allow Lodges to hold legal charitable raffles conducted in compliance with the laws of the State of Texas.

**No. 14:** Added Article 20c requiring the appointment of a Trustee Audit Committee to bring the Grand Lodge of Texas in compliance with applicable laws regarding nonprofit organizations.

**No. 15:** Amended Article No. 45 to accurately delineate the duties of the Grand Treasurer.

**No. 16:** Final approved wording:

Therefore be it resolved that the Home and School cease operation and be closed as soon as possible.

Be it further resolved the Trustees of the Grand Lodge, in cooperation with the Directors of the Masonic Home and School, be directed to initiate all necessary actions to comply with this directive in a Masonic manner to accomplish an orderly, efficient and legal closing of the Home and School and report their actions at the 2004 Annual Grand Communication.

**No. 26:** Amended Art. 625 by requiring life expulsion for any Mason found guilty of, or who enters a plea of guilty, or of no contest, to a charge of pedophilia or related charges.

**No. 27:** Amended Art 20b to require that the annual audit of the Grand Lodge of Texas be conducted by an independent auditor not associated with an individual or firm that provides accounting services to the Grand Lodge or with any member of the Finance Committee.

**No. 30:** Amends Art. 3, 4 and 5 related to the election and certification of Lodge proxies to the Grand Annual Communication.

**No. 34:** Add new paragraph 13 to Art. 163 to increase the per capita dues by \$1.00, and the funds being remitted to the Masonic Youth Foundation. Current paragraph 13 is also renumbered paragraph 14.

**No. 35:** Amends Art. 46 to increase the bonding requirement for the Grand

Secretary to a minimum \$50,000 and adds new Art. 46a requiring that the Grand Secretary's salary be listed as a budget item.

**No. 36:** Amended Art. 121 requiring that each member of Grand Lodge and each Lodge representative be provided a printed copy of the proposed budget of the Grand Lodge before it is presented to the Grand Lodge for discussion and final approval.

The Grand Lodge also approved that the **Golden Trowel Award** be limited to one per year and that the time frame for that year shall be the Masonic year.

# NEWS from HOME

Dear Brethren,

Article X, Section 1, of the Constitution of the Masonic Grand Lodge of Texas states that the Grand Lodge of Texas has “from its organization in 1837 to the present time, undertaken to provide for the maintenance of the widows and for the education and maintenance of the orphaned children of deceased members of the Fraternity.” Additionally, Article X, Section 1, provides that the Grand Lodge of Texas “does hereby pledge anew its sacred honor to the accomplishment of this noble design, and will devote to its full and continued realization the financial resources at its command and all that may be achieved by the earnest thought, generous hearts and willing hands of our great Fraternity.”

Article X, Section 1, has not been repealed.

The members of the Grand Lodge of Texas at the December 2003 Grand Annual Communication expressed their intent to close the Masonic Home and School, which is provided for in Article X, Section 2, of the Constitution wherein it is stated that the Masonic Home and School “is recognized as a means of the attainment of the commendable purposes above set forth” in Article X, Section 1.

The widows were removed from the Masonic Home and School in approximately 1912. We take care of our widows by outsourcing them in the Texas Masonic Retirement Center, formerly the Home for Aged Masons, operated by the Grand Royal Arch Chapter of Texas.

We are still obligated to take care of both the widows and the orphans. We will be outsourcing our children to be taken care of by others at other facilities, but we are still obligated to take care of our children. Just because the Home and School is going away does not relieve us from our financial, moral and Masonic responsibility to our widows and children. We must continue to financially support our widows and children. If your Lodge has not made its usual financial gifts to the Home and School, please reconsider and make those gifts, since these gifts support both the widows at the Retirement Center and the children wherever they may be.

Unless and until we repeal Article X, Section 1, of the Constitution and a part of our Master Mason’s obligation, we are obliged always to contribute to the relief of the poor and penniless Master Masons, their widows and orphans. Please let your heart be expanded by benevolence in continuing your support of our widows and orphans.

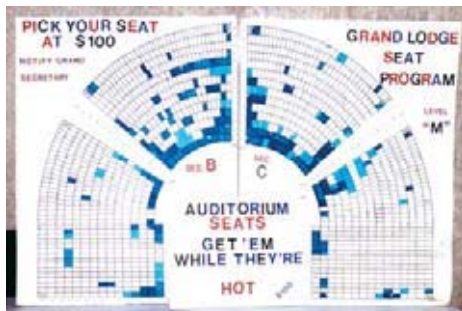

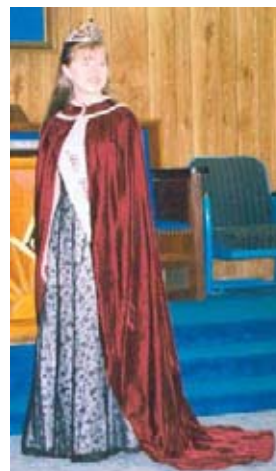
